# Salem Microenterprise & Small Business Relief Grant Program

The City of Salem is offering microenterprise and small business relief grants of up to \$10,000 to be used to offset the negative business impacts of the COVID-19 pandemic. The program is open to for-profit Salem businesses with a brick and mortar location. Funding can be used to offset payroll costs, rent and mortgage payments, utilities, and loss of inventory due to mandatory closures. The program provides short-term working capital assistance to support businesses and retain jobs during the severe economic interruption caused by the COVID-19 pandemic. ### **Expansion of Unemployment Assistance**

On April 20, 2020, the Commonwealth of Massachusetts launched the online application for the newly created **Pandemic Unemployment Assistance (PUA)** program that provides up to 39 weeks of unemployment benefits to workers not traditionally eligible for unemployment benefits (self-employed, independent contractor, gig economy worker, freelancer, worker with limited work history, and others) who are unable to work as a direct result of the coronavirus public health emergency. PUA recipients will also receive an additional \$600 weekly benefit through the Federal Pandemic Unemployment Compensation (FPUC) program.

What you need to Apply for Pandemic Unemployment Assistance:

- Your social security number
- If you are not a citizen of the United States, your A Number (USCIS Number)
- Your residential address
- Your mailing address (if different from residential address)
- Your telephone number
- Your email address
- Your birth date
- Your wage records for 2019: 1099 forms, pay stubs and bank statements
- The social security number(s) and date(s) of birth for your dependent child(ren)
- If you want to use direct deposit for payment, your bank account and routing numbers
